### SELF DECLARATION FORM

#### AGREEMENT, RELEASE, WAIVER, INDEMNITY AND ASSUMPTION OF RISK

**I AGREE THAT:**

1. At all times during my presence on or use of the facilities of the RCFCT FIELD (the "Field"), my safety and the safe use of my model aircraft and the equipment therefor remains my sole responsibility and I will at all times observe the rules established by the Field; and

2. I will immediately discontinue flying my aircraft at the Field if it is determined by any representative of the Field at any time that I have failed to follow such rules or that any of my aircraft are unfit to be flown; and

3. I am aware of the dangers and risks to persons and property inherent in flying model aircraft and voluntarily and with full knowledge assume all such risks. IN CONSIDERATION of the Field allowing me onto its premises, or to use its facilities, I for myself, my heirs, executors, administrators, successors and assigns HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE the Field and RCFCT in trust, all their respective beneficiaries, owners, officers, directors, agents, employees, servants, representatives, and their successors and assigns (collectively the "Releasees") FROM ALL causes of action, claims, demands, damages, costs, and expenses whatsoever, in respect of death, injury, loss or damage to my person or property, and to the person and property of all others, HOWSOEVER CAUSED, arising or which may arise by reason of my presence at the Field, my use of any of its facilities, or my flying model aircraft from it, or otherwise; AND NOTWITHSTANDING that same may have been contributed by the negligence (active or passive) or breach of contract of any of the Releasees. I AGREE TO INDEMNIFY AND SAVE HARMLESS the Releasees from and against all liability incurred by any or all of them arising as a result of or in any way connected with my having been present at the Field, or my having used any of its facilities, or my flying model aircraft from it, including directly or indirectly causing death, injury, loss or damage to any persons and loss or damage to any property whether any such persons or property are located on or off the premises of the Field.

I ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS DOCUMENT, THAT I FULLY UNDERSTAND IT, AND UNDERSTAND THAT BY SIGNING IT I AM RELINQUISHING ANY AND ALL RIGHTS THAT I HAVE, OR ANY OF MY DEPENDANTS, HEIRS, EXECUTORS OR ADMINISTRATORS MIGHT HAVE AGAINST THE RELEASEES FOR ANY LOSS, DAMAGE, INJURY OR EXPENSE SUFFERED BY ME, INCLUDING THE RIGHT TO SUE THE RELEASEES. I WARRANT THAT I AM A COMPETENT FLIER OF MODEL AIRCRAFT AND THAT TO THE BEST OF MY KNOWLEDGE ALL OF MY EQUIPMENT IS MECHANICALLY AND ELECTRONICALLY FIT AND SUITABLE FOR ITS INTENDED USE, AND I ACKNOWLEDGE THAT THE REPRESENTATIVES OF THE FIELD ARE RELYING ON THIS WARRANTY AND AGREEMENT, RELEASE, WAIVER, INDEMNITY AND ASSUMPTION OF RISK IN ALLOWING ME ONTO THE FIELD.
